



Traditional scheme



- Distinct acts of communication to the public (Berne Convention, SatCab Dir)
 - 1. Broadcast ("primary" exploitation)
 - 2. Cable transmission ("secondary" exploitation)
- Special regime for "cable retransmission" (SatCab Dir)
 - Mandatory collective management
 Ratio: facilitating clearance of rights
 - Exception: broadcaster

Legal controversy

DALDEWOLF

- Litigation > 30 years
- Recent issues:
 - Cable retransmission mandatory collective management
 - By CMO of AV producer
 Transfer of rights by contract/legal presumption
 No additional remuneration for authors/performers
 - By CMO of AV authors/performers
 Membership of CMO + ratio legis (facilitating licensing)
 Additional remuneration for authors/performers
 - Direct injection

Single protected act = generic communication to the public?

⇒ Individual management

Two protected acts = cable retransmission?

- European directive (2019)

Legal framework

- Berne Convention 1971
- WIPO Copyright Treaty 1996
- Directive 93/83/EEC of 27 September 1993 on the coordination of certain rules concerning copyright and rights related to copyright applicable to satellite broadcasting and cable retransmission ("SatCab Dir")
- Directive 2001/29/EC of 22 May 2001 on the harmonisation of certain aspects of copyright and related rights in the information society ("InfoSoc Dir")
- Directive 2006/115/EC of 12 December 2006 on rental right and lending right and on certain rights related to copyright in the field of intellectual property ("Rental Dir")
- Directive 2019/xx of xx laying down rules on the exercise of copyright and related rights applicable to certain online transmissions of broadcasting organisations and retransmissions of television and radio programmes

Legal framework (2)

- Belgian Code of Economic Law
 Book XI. Title 5, chapter 4 communication to the public by satellite, retransmission by cable and communication to the public by direct injection
 - Cable retransmission: art. XI.223 -225 CEL (amended by Act 19 April 2014)
 - Direct injection: art. XI.226-227/1 CEL (introduced by Act 25 November 2018)
 - Common provisions: art. XI.228-228/1 CEL (amended and introduced by Act 25 November 2018)

Definition; principle

CABLE RETRANSMISSION

Cable retransmission:

The simultaneous, unaltered and unabridged retransmission by a cable or microwave system for reception by the public of an initial transmission, by wire or over the air, including that by satellite, of television or radio programmes intended for reception by the public

- 2 transmissions
- 2 acts of communication to the public
 - Initial communication by broadcaster
 - Second communication by cable operator
 - Cable retransmission = exclusive right
 - Independence of both exploitations
- PM: definition to be amended by Retransmission Directive 2019?

"Communication to the public by direct injection"; definition; principle

DIRECT INJECTION

Art. I.16, §1, 7° CEL

"7° directe injectie: de techniek waarbij een omroeporganisatie haar programmadragende signalen uitsluitend aan de distributeurs van signalen doorgeeft zonder dat die signalen tijdens en naar aanleiding van die doorgifte toegankelijk zijn voor het publiek, en waarbij die distributeurs de signalen vervolgens naar hun respectievelijke abonnees sturen, zodat deze de programma's kunnen ontvangen."

"7° injection directe: la technique par laquelle un organisme de radiodiffusion transmet ses signaux porteurs de programmes exclusivement aux distributeurs de signaux, sans que ces signaux soient accessibles au public au cours et à l'occasion de cette transmission, ces distributeurs envoyant ensuite lesdits signaux à leurs abonnés respectifs afin que ceux-ci puissent recevoir ces programmes."

- Technique
 - No definition of the protected act
 - No exhaustive list of "techniques" (cable, fiber, IPTV) "technology-neutral"
- Broadcaster transmits (1) programme-carrying signals
 - Exclusively to distributor
 - Signals not accessible to the public
- Distributor transmits (2) to its subscribers for reception

Definition (3)

DALDEWOLF

- Two (linear) transmissions
 - Broadcaster >> distributor
 - Distributor >> public (subscribers)
- Question: "exclusive" = ?
 - One-on-one transmissiontechnical interpretation => many acts
 - Also only form of exploitation?only exploitation => fewer acts
 - ⇒ Technical or editorial criterion?

Relevance:

- BE exploitation >< foreign exploitation
- BE: parallel online exploitations

- Two transmissions one, single act of communication to the public
 - Exclusive rights (art. XI.226 CEL)
 - Authors
 - Holders of neighbouring rights
 - Responsibility (art. XI.226/1 CEL)
 - Broadcaster and distributor "together"
 - No joint liability
 - Each clears rights for its contributory transmission
 - Absent OK for one transmission => infringement => cessation?

Remuneration right, mandatory collective management, single platform, information obligation, conclusions

LEGAL CONSEQUENCES

- Before 2018 reform
 - Cable retransmission or generic communication to the public
- Since 2018 reform
 - Cable retransmission / direct injection / (generic communication to the public)
 - Uniformisation of applicable rules
 Qualification still relevant but difference less impact than before 2018

- Right to remuneration
 - For author + performerNot: producer
 - Cable retransmission (since 1 January 2015) and direct injection (from 1 July 2019)
 - If transfer of exclusive right to producer
 - Exploitation by producer
 - Remuneration for author/performer

Features

- Non transferrable, non waivable (= mandatory)
- In addition to exclusive right (producer)
- Amount to be negotiated (no legal criteria)

Collective management

- Mandatory collective management
 - Cable retransmission
 - Broadcast: individual management
 - Cable retransmission: collective management
 - Exclusive rights => CMO producerException: broadcaster
 - Remuneration rights => CMO author/performer
 - Direct injection
 - Transmission by broadcaster: collective management
 - Exclusive rights => CMO producerException: broadcaster (acquisition from producer)
 - Remuneration rights => CMO author/performer
 - Transmission by distributor : collective management
 - Exclusive rights => CMO producer
 Exception: broadcaster (transfer from broadcaster to distributor)
 - Remuneration rights => CMO author/performer

Single platform

DALDEWOLF

- Uniek platform / plateforme unique
 - Broadcasters, CMOs exercising exclusive rights, CMOs exercising remunerations rights
 - Purpose:
 - Facilitating collective negotiations with distributors
 - Collective agreements on conditions and modalities of exploitation
 - No criteria
 - Determining amounts
 - Debtors of remunerations
- Until then:

payment by distributors &/ broadcaster

- Obligation to exchange appropriate and sufficient information, in timely manner
 - Producers, CMOs, broadcaster, distributor (satellite, cable, other)
 - Purpose:
 - Qualification (broadcast, communication by satellite, cable retransmission, direct injection)
 - Economic basis for calculating remuneration
 - Determining remunerations (already or yet to be collected)

- Improvement
 - Legal certainty "direct injection"
 - Elimination of anomalies
 - Potential increased transparency
- However
 - Subsisting legal uncertainty "direct injection" / "cable retransmission" / generic communication
 - Technical criterion / editorial criterion?
 - Quid "broadcaster" online "primary" transmissions
 - Importance: find coherent criterion avoid lacunas or default application of generic communication
 - Finding agreement on remunerations
